## **INSTRUCTIONS AND ADDITIONAL INFORMATION TO CANDIDATES FOR ADMISSION**

**2. CITIZENSHIP:** A Candidate must be either: (a) a citizen of India, or (b) a subject of Nepal, or (c) a subject of Bhutan, or (d) a Tibetan refugee who came over to India before 1st January, 1962 with the intention of permanently settling in India, or (e) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka or East African countries of Kenya, Uganda, the United Republic of Tanzania(formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India. Provided that a candidate belonging to be a person in whose favour a certificate of eligibility has been issued by the Government of India. NOTE The application of a candidate in whose case a certificate of eligibility is necessary, may be considered by the GPS and, if recommended for admission, the candidate may also be provisionally admission subject to the necessary certificate being issued in his favour by the Government of India.

**3. AGE LIMITS:** No age bar.

**4. MINIMUM ESSENTIAL QUALIFICATIONS:** All applicants must fulfil the essential requirements of the admission and other conditions stipulated in the advertisement. They are advised to satisfy themselves before applying that they possess at least the essential qualifications laid down. No enquiry asking for advice as to eligibility will be entertained.

NOTE-I: The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for exam.

NOTE-II: IN THE EVENT OF NUMBER OF APPLICATIONS BEING LARGE, GPS WILL ADOPT SHORT LISTING CRITERIA TO RESTRICT THE NUMBER OF CANDIDATES TO BE CALLED FOR EXAM/INTERVIEW TO A REASONABLE NUMBER BY ANY OR MORE OF THE FOLLOWING METHODS: (a) On the basis of higher educational qualifications than the minimum prescribed in the advertisement.

<b>IMPORTANT</b>
(i) The minimum level of suitability in admission, irrespective of whether the selection is made only by interview/counselling or by Test followed by interview/counselling. <b>Examination question will be asked from study material only.</b>

**5. APPLICATION FEE:** (a) Candidates are required to pay a fee of registration for application of Rs. 200/- only by using net banking facility of the SBI or by using visa/master credit/debit card. No "fee exemption" is available any candidates and they are required to pay the full prescribed fee. (b) Applications without the prescribed fee would not be considered and summarily rejected. No representation against such rejection would be entertained. (c) Fee once paid shall not be refunded under any circumstance nor can the fee be held in reserve for any other examination or selection. (d) After the selection of candidate for admission there is 8500/- rupees donation towards to development of institution is mandatory paid and once paid shall not be refunded under any circumstance nor can be held in reserve for any other examination or selection.

**6. HOW TO APPLY:** i) Candidates must apply online through the website <https://sainiofficials.com> Applications received through any other mode would not be accepted and summarily rejected. ii) Candidates must upload the documents/certificates in support of all the claims made by them in the application like, Date of Birth, educational qualification or any other as applicabale (preferably in prescribed format), Desirable Qualification(s) etc. or any other information, each claim in pdf file. The "UPLOAD OTHER DOCUMENT" and is legible when a printout taken.

**Upload of Photograph & Signature:**

- (i) In the online Application Form, candidates are required to upload the scanned colour passport size photograph in JPEGs format ( upto 100 KB). The photograph should not be more than three months old from the date of publication of the Notice. The photograph should be without cap, spectacles and both ears should be visible. **Applications with blurred photograph will be rejected. If the proper photograph is not uploaded by a candidate, his candidature will be cancelled.**
- (ii) Scanned signature in JPEG format ( up to 100 KB). Image dimension of the signature should be about 4.0 cm (width) x 2.0 cm (height). Applications with illegible/ blurred signature will be rejected.

#### **Upload Documents:-**

- a) Matriculation/10th Standard or equivalent certificate indicating date of birth, or mark sheet of Matriculation/10th Standard or equivalent issued by Central/State Board indicating Date of Birth in support of claim of age. Where date of birth is not available in certificate/mark sheets, issued by concerned Educational Boards, School leaving certificate indicating Date of Birth (in case of Tamil Nadu& Kerala).
- b) Degree/Diploma certificate as proof of educational qualification claimed. In the absence of Degree/Diploma certificate, provisional certificate along with mark sheets pertaining to all the academic years.
- c) Order/ letter in respect of equivalent Educational Qualifications claimed, indicating the Authority (with number and date) under which it has been so treated, in respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement.
- d) Caste certificate of Mali(Saini) community by candidate seeking admission by the competent authority indicating clearly the candidate's Caste, the Act/ Order under which the Caste is recognized as OBC and the village/ town the candidate is ordinarily a resident of.
- e) Certificate of Disability in prescribed proforma issued by the competent authority to Persons with Benchmark Disabilities (PwBD) eligible for admission on the basis of prescribed standards of Medical Fitness. - f) Documentary support for any other claim(s) made. Note: If any document/ certificate furnished is in a language other than Hindi or English, a transcript of the same duly attested by a Gazetted officer or notary is to be uploaded.
- g) Character certificate/ Caste verification issued by the any Mali (Saini) community registered Sansthan or Any Saini Officials Member & Donner of GPS or Donner of GPS. (i) **IMPORTANT: IT IS NOT REQUIRED TO UPLOAD WHILE ONLINE ADMISSION APPLICATION. HOWEVER, IT IS MANDATORY TO BRING DURING INTERVIEW/COUNSELLING/ADMISSION.**
